What is ...


... Care to Learn?

- Care to Learn is a government scheme that helps young parents pay for childcare while they study.
- It can also help cover extra travel costs for getting your child to and from childcare.
- If your course includes work placements, Care to Learn can help pay for childcare during those too.



... can apply?

You can apply if:



- You're the **main carer** of your child (and receive Child Benefit for them).
- You live and study in **England**, with the legal right to live here.
- You use a childcare provider who is properly registered with Ofsted.
- If you turn 20 during your course, you can continue getting support until the end of that course.

If you're not a UK citizen

You can still apply if you have one of these:

- Refugee status
- Humanitarian protection
- Discretionary, limited or indefinite leave to remain/enter
- Leave outside the rule



Or, if you're an asylum seeker under 18 (or 18–19 and a care leaver), you can apply with proof from your local authority.



What childcare...



... can it pay for?

Your childcare must be registered with Ofsted. This includes:

- Nurseries, childminders, or childcare agencies on the Early Years Register or General Childcare Register.
- School-run clubs (like breakfast or after-school clubs) that are exempt from registration.
- Relatives only if they:
 - Live at a separate address from you and your child, and
 - Care for at least one other unrelated child, and
 - Are Ofsted-registered.

How much ...

... can I get?

You can get:

- Childcare: up to £180 per child per week (paid directly to the childcare provider).
- Travel costs: for journeys between home and childcare (if this is in addition to your normal journey to college).
- Mileage is paid at 25p per mile if you drive.
- The maximum combined support (childcare and travel) is £180 per week.





You need to fill in a **new application every academic year**.

- Download the application form here: <u>Financial-Support-Care-to-Learn-Childcare-Application.pdf</u> or email **funding@runshaw.ac.uk** to request one.
- 2. Gather your documents:
 - Your child's birth certificate or a letter showing you receive Child Benefit.
 - Proof of your travel costs (if claiming travel support).
- **3.** Complete the form (including childcare provider details).
- Return the form to <u>funding@runshaw.</u>
 ac.uk or hand it in at Student Services.

We'll confirm in writing if your application has been approved and send you (and your childcare provider) a payment plan.

What you need to tell us

You must let us know straight away if:

- Your childcare arrangements or provider change.
- Your study hours or programme change.
- Your travel arrangements change.
- Your residency or immigration status changes.

What about work placements?

If your course includes compulsory work placements, **Care to Learn can cover** childcare during **those hours too**.

When will I hear back?

Once you've applied, we aim to confirm your eligibility and payment plan **within 10 working days** (during term time).

What if I disagree with a decision?

You can appeal within 10 working days of receiving your decision.
